Format

EACH ROUND WILL BE PLAYED WITH A DIFFERENT PARTNER.

The draw is filled when the **first 8 players** sign up in each event.

7 rounds are played: two rounds Friday, three rounds Saturday and two rounds Sunday.

Each round will consist of thirteen regular games, with the thirteenth game being a 12-point set tiebreaker (first to 7 points).

The total of all games won after playing seven rounds will determine the winner. Prizes will be awarded to 1st and 2nd place finishers.

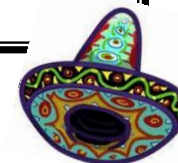
